Subject: Denunciation

It is about two years now that the citizen Dilaver Ymeri (next to our Mission) and the Firm I & L Shpk (which works for him) has demolished 6 m² of levanters, 8 m² of privets and has moved a heap of earth of about 12.8 m² in the Holy Mission Eleonorë. It has also moved a heap of earth of about 61 ml under a lane. The situation is urgent because the movement of a massive heap of earth risks two of our edifices as well as the contribution and devotion of the spiritual activity of thousands of people. We are working for the situation not to aggravate because the situation ia alarming and tense.

Honourable Sir,

With reference to the continuous and violent acts of the citizen Dilaver Ymeri against the Holy Mission Eleonorë, we also made the denunciation at Police Station 1, Tirana a year ago, on 23.06.2005, when the chiefs of the Police Station were Mr. Idajet Hoxha and Astrit Demollari, and the chief of order was Taulant Kondi (we have made a denunciation against the last one at SH.K.B. for his one sidedness and for exceeding his competences).

We have been in an alarming situation for two years because the problem has not been solved. This citizen pretends that his property lies on a part of our Mission. Even though this is a civil conflict to be solved by the court, hepreferes to solve it forcefully.

The event It is about a year and a half that the citizen Dilaver Ymeri together with the Firm I & L SHpk which works for him has been encroaching seriously the edifices of the Holy Mission Eleonorë. The work is being done out of technical condition. During the last two months this firm has started to demolish a concrete lane of about 61 ml, and tens of plants and levanters. The situation was aggravated some months ago when these people together with the Private Police "SAFE" exercised physical violence on the women, girls and the

family of the Spiritual Leader of this Mission. We made the denunciation at Tirana Public Prosecutor, but the authors have not been found yet.

We request

1. Work stoppage of this Firm up to the finding of a technical solution in order not to encroach the site of the Mission and the religious activity.
2. The liquidation of the damage caused by the citizen Dilaver Ymeri. We think our request is based on the provision the Albanian legislation gives us to exercise our spiritual activity and the nonencroachment of our site as we are in the process of legalisation and the state is trying to find the possible solution through a group of experts.

Being convinced of your statement on the implementation of the law and the priority you are going to give us as a humanitarian and spiritual Mission, we look forward to the solvation of the problem and the appeasement of our people.

LENDA: DENONCIM

Ne Misionin Shenjteror Eleonore qe prej 2 vjetesh e deri me sot shtetasi Dilaver Ymeri (kufitar me Misionin tone) dhe Firma I&L Shpk (qe ndjek punimet)ka shembur 6 m2 levantina, 8 m2 ligustra, ka shkaktuar nje levizje masive dheu prej 12.8 m2, si dhe hoqi dheun e poshtem te nje rrugice prej 61 ml. Situata eshte emergjente sepse levizja masive e dheut rrezikon dy objekte kulti nga tonat si dhe kontributin dhe perkushtimin e veprimtarise shpirtore te mijera njerezve. Ne po punojme qe situata te mos pershkallezohet sepse gjendja eshte alarmante dhe e tensionuar.

I nderuar Zoteri,

Ne lidhje me veprimet e dhunshme te njepasnjeshme te shtetasit Dilaver Ymeri kundrejt Misionit Shenjteror Eleonore, kemi denoncuar prane Komisarati nr.1 Tirane edhe nje vit me pare me date 23.06.2005 kur Shef Komisarati ishte Z. Idajet Hoxha dhe Astrit Demollari, si dhe Shef Rendi Taulant Kondi (ku per kete te fundit kemi denoncuar dhe ne Sh.K.B. per tejkalim kompetencash dhe njeanshmeri).

Per shkak te moszgjidhjes se ketij problemi prej 2 vjetesh, sot ndodhemi ne nje shtete teper alarmante. Ky shtetas ngre pretendimin se pronesia e tij shtrihet edhe ne nje pjese te Misionit tone, por edhe pse ky eshte nje konflikt civil per ne gjykate, ai do ta zgjidhe forcerisht.

Ngjarja

Ka me shume se nje vit e gjysem qe shtetasi Dilaver Ymeri se bashku me firmen I&L Shpk qe kryen punimet ne favor te tij, po cenon rende gjithnje e me shume objektet fetare te Misionit Shenjteror Eleonore. Keto punime kryhen jashte kushteve teknike. Ne keto kushte vetem gjate 2 muajve te fundit kjo firme ka filluar te shembe nje rrugice betoni prej 61 ml, dhjetera bime, lule, ligustra, levantina, etj.

Ngjarja u pershkallezua disa muaj me pare, kur keta njerez se bashke me punonjes te policise private "SAFE" ushtruan dhune fizike mbi grate, vajzat dhe mbi familjen e udheheqeses shpirterore te ketij Misioni, per te cilet kemi bere kallezim penal ne Prokurorine Tirane dhe ende nuk jane gjetur autoret.

KERKOJME:

1. Te nderpriten punimet e kesaj firme deri ne gjetjen e nje zgjidhje teknike per moscenimin e truallit te Misionit tone dhe veprimtarise fetare.
2. Shlyerjen e demit te shkaktuar nga shtetasi Dilaver Ymeri. Mendojme qe kerkesa jone eshte e mbeshtetur ne dispozitat qe na lejon legjislacioni shqiptar per ushtrimin e veprimtarive shpirterore dhe moscenimin e truallit ku jemi ulur persa jemi ne proces legalizimi dhe shteti po perpiqet per nje zgjidhje te mundshme permes nje grupi ekspertesh.

Te sigurt ne prononcimin Tuaj per zbatueshmerine e ligjit, dhe perpresine qe do te na jepni si Mision shpirteror e humanitar, mbetemi ne pritje te zgjidhjes se problemit dhe qetesimit te njerezve tane.
