With reference to the official document Prot/Number 194 date 17.11.2006 which is about your Mission's complaint in relation to the conflict you have with the citizen Dilaver Ymeri and the firm working for him, we explain that:

1. The request about the work stoppage of the Firm is not in our competence. It is the competence of the Construction Police in collaboration with the local government.
2. The liquidation of the damage caused by the citizen Dilaver Ymeri is not attribute of the State Police. It is the competence of the court to decide on the solvation of the problem

We stress that this conflict is treated by us on time based on law 8553 for the State Police. We are waiting to support the execution of the verdict of the court by the Bailiff's office.

Thank you for the understanding.

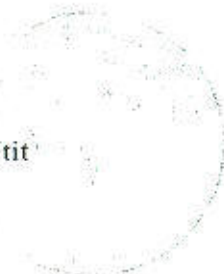
