

## The History of a Crime

### The Incident

On May 24, 2007, at 01:00 am, two unidentified individuals, masked with special clothes (such as plastic laminated clothes, gloves etc) entered in the bedroom where Lady of Soul Eleonore after had performed a Spiritual session (Praying session) and went to sleep.

Eight hours later, around 9:30 am, one of the Lady of Soul's daughters, Florida, found Lady of Soul having convulsions, vomit, diarrhea and often intense sweating. She called for help and in few minutes emergency came in and they gave to Lady of Soul the first aid, such as serum and medication, helping Her vomiting again, since they thought the convulsions must be the last signs of Her life.

After few hours of the first aid treatment, Lady of Soul Eleonora Bregu, was able to reveal what happened and declared for media, attorney and all public:

“Today, around 1:00 am, I heard the noise of forcefully window opening and the fallen weight and later I noticed people. I opened my eyes, it was such unusual situation. I saw two men with black mask, white shoes like those used in an intervention room, with black gumming clothing, like diving uniforms, wearing black gloves not to leave any fingerprint. They almost did not talk at all. They turned towards me and by signs told me not to speak. I asked: Who are you? What do you want? Why have you entered in our Mission? Two hands open my jaws; another hand closed my nose and with the next hand put in to my mouth a hospital bottle not a usual one with a white liquid which they held tight. I tried to resist, but I was forced to swallow, there was no other choice. “We will eradicate you, your family and Your Mission” they said to me.” They left the room where I was staying and I heard their steps as they were entering in the other facilities of the Holy Residency. I heard noise that was like the sound of camera. After their criminal poisoning attack they were communicating with each–other and saying: “the materials take everything, let's destroy all the material evidence”. They went out through the same window they had entered.”

After the attackers left, Lady of Soul dragged on and with her maximum left strength she could write a letter for her children and community:

***“Mamma, two masked people poisoned me, they took my body but not my Mission. Praise God!”*** (Signed from her at the end)

After the criminals left, Saints, Entities and angels worked to protect the Lady of Soul's brain, heart and vital organs. Thanks God and Spirituals Alliance, Lady of Soul survived against poisoning effect for more then nine hours and half, until the doctors arrived and were able to give the first medical aid. Recently, Lady of Soul is conscious, and she is full filling her duty functions of spiritual aspect as well as administrative.

### The Latest Developments on the day of crime

For security reasons, and the lack of confidence in some of the incriminated instances in Albania, on May 25, 2007, Lady of Soul left for Turkey, to the American Hospital of Istanbul for treatment such as:

- To get a special medical treatment and for safety and security of the life of Lady of Soul as well.

- To go through more detailed examination in order to preserve her vital organs.
- To identify the chemical substance used during the poisoned attack, on May 24, 2007.

The results of the medical examination done in the American Hospital in Istanbul revealed that:

The Lady of Soul has been intoxicated with a somnolent chemical substance (with effect lasting up to 3 to 5 days), known from the medicine as a benzodiazepine.

Based on the medical reports this chemical causes:

- Coma condition.
- Impairment of the memory and psychological processes of the Lady of Soul, damage of the nervous system, disabling her performing the Divine Connection.
- Physical body paralysis.
- Death (which, based on the medical staff, has been a case for many individuals).

Based on our confidential sources, those experts mentioned that this poison it's hard to be found, and this poison has been used during the World War II (in Holocaust) and from that time it has been banned from usage. Furthermore, in many countries its usage has been prohibited by law.

Based on the above mentioned facts and analyzing this suicide attempt, it's clear we are dealing with highest professional killers. That makes us be aware of the level of danger and how cautious we should be. Furthermore, the attackers declared to the Lady of Soul that their purpose was the physical elimination of the Lady of Soul and the Holy Mission Eleonore. Observing the passivity of the investigative team from the police department and their lousy job in gathering the evidence from the scene of crime, (which we had doubt was intentional and not professional), urged us to send Lady of Soul in Turkey in order:

- To protect her physical integrity.
- To avoid the interference of the individuals who are not interested in the true analyze results.

### **The Main Possible Reasons for the Attack**

If we will have a retro insight from the first moment of the attack, and the outcome of it if the attempt murder was successful, we would think several reasons leading to this attack.

**First**, It is an attack against Mission Eleonore intending to eliminate the leader as the necessary step to destroy the Mission. It is "unpleasant" for a patriarchal society as Albania, to have among other religions, a Mission of such dimensions leaded by a Lady. And what makes it more "unpleasant", it is the fact that for the first time the Divine Connection has been given to a woman with motherhood and womanhood attributes such as: The preservation of life in an unconditional way, way which goes contrary to the religions history where the man has been in more privileged level than woman in a relation with God.

**Second**, it intends to destroy the ongoing spiritual contact of the Lady of Soul with the Divine Connection. Lady of Soul Eleonore is the only spiritualist on Earth mastering the Spiritual Code able to have a Divine Connection, God; therefore, the usage of this

poisoning compound would cause the erase of memory and elimination of the Spiritual Divine Connection.

**Third:** The Holy Mission Eleonore is the latest Discovery up to now, which brings a new idea and a modern point of view to understand the human, the world, God, Holiness in general and their application. This represents our Missionary Doctrine, materialized in two spiritual and philosophic books of Lady of Soul “The Human in front of being” and “The Cosmos and Us”, which among other things are suggesting “***Believe through logics and reason***”.

Believe through reason, in our Mission, means the application of the other consecration of this new Divine Alliance: “***It is permitted everything which serves and protects life; it is prohibited anything that harms life***”. It’s the adversary of some religious dogmas today which spread and apply the idea that in the Name of God and religion you can set bombs and kill hundreds if thousands of people; furthermore, using the existence of God to stop and prejudice the scientific achievements, by misinterpreting and misusing the existence of God as a Creator and defendant of life, thus causing a religious instability.

**At fourth:** The attempt to eliminate the Lady of Soul happened just few days prior the very important visit of President G. W. Bush in Albania. In this contest, they tried to do everything in the verge of the visit of His Excellence, to escalate and accelerate this religious contradiction, and it was attempted to cause a political de-stability in Albania.

### **Mass Media Allusions on this Attack**

We would like to thank that part of mass media that had an independent stance by following the occurrence based on chronology, facts, confession as it happened.

However, for the mass media who intimated that all of this was a prefabricated event, totally ignoring the medical and legal conclusion which proves in a scientific way the attempt of poisoning murder attempt, we have only one question:

*Why are you surprised for the trifulness of this incident?*

The history tells us that all the Missionaries who brought a New Discovery, which by time has been developed into a religion, have been attacked, killed, crucified, buried alive, have been poisoned, have been humiliated and offended etc. Thus, is the same shameful history which has been repeated. Meantime, it does not have any reason why the Lady of Soul had to improvise such an event because at the time of attack she had a good physical and mental health. Furthermore, there were hundreds of members and medical staff present after the attack that witnessed the convulsions and vomit and gave the first aid.

Regarding other hypothesis, which was thrown out from some mass media, we would like to inform that this attack cannot be done from the property-involved pretenders. This because the conflict with Mr. Dilaver Ymeri were solved and regarding the tribunal case with Vorpsi Family, the matter was turned on our favor based on the fact that we investigated and proved that their documents were false with legal and technical irregularities. So, we do not have any recent properly-related conflict even from the fact that from November 2006 we started the legalization procedures.

**Conclusion**

This is a religion war which aimed the physical and spiritual elimination of the Lady of Soul Eleonore and Holy Mission Eleonore. For further detailed explanations regarding this religious war and the attack, the Lady of Soul declares that she is willing to cooperate not only with the competent authorities which have set a penal procedure and are investigating on this attack, but on the same attitude is willing to deal with the mass media, psychologists, philosophers, jurists etc., to explain everything regarding her mental health and her value of the Missionary aspirations.

Our Mission Community is asking the President of the Republic of Albania, Mr. Alfred Moisiu, Prime Minister of Albania Prof. Dr Sali Berisha as well as the other related instances, for the protection and physical integrity of our Mission Leader, Her family and Her Mission that She is leading for 20 years.
